2010 Awards Program

The Montrose Wolf Distinguished Contributions Award recognizes an individual for his or her contribution to the Association and to the development, refinement, and implementation of the Teaching-Family Model. This category recognizes those persons who have provided significant contributions to the Teaching-Family Association program administration, staff training, evaluation technology, or research that extends our knowledge and otherwise enhances the application of the Teaching-Family Model. Past recipients have included Patrice White, Dean Fixsen, and Robert "Bud" Milner and others, including Montrose Wolf himself.

The Lonnie & Elaine Phillips Award is an Association Level Practitioner award that recognizes a certified practitioner couple or individual from a certified or developing agency for their outstanding contribution to the Association as implementers of the Teaching-Family Model in any Teaching-Family treatment setting and for making a significant contribution to the Teaching-Family Association. This category includes (a) exceptional service to program consumers, (b) innovative applications of the Model to families and new populations, (c) the development or refinement of program technology, (d) contributions to training and to the Teaching-Family practitioner profession, and (e) involve-

ment with and contributions to the Teaching-Family Association.

Past recipients include Ed and Shelly Dalzell, Cory and John Richardson-Lauve, Ken & April Hayward (2009) and others.

New in 2010 is the Teaching-Family Association Award for Outstanding Achievement & Advancement in Human Services. This award is being provided to any individual and/or organization who has contributed to the awareness and advocacy on behalf of children and families.

The Association also enables each Certified Member Agency to recognize an outstanding Teaching-Family Practitioner (individual or couple) at the fall Annual Conference. Thus the Committee is also seeking designees for the Teaching-Family Association Distinguished Service Award. This category recognizes outstanding Teaching-Family Practitioners at each Certified Member Agency who, for a variety of reasons, may or may not be actively involved in our international organization, but who have provided outstanding service as Teaching-Family

Making a Nomination

Association-Level Awards

Any member of the Teaching-Family Association may make a nomination for any Association-Level award. The attached nomination forms must be submitted by 1 October. After all nominations are collected, the committee will contact nominators for at least one letter of nomination/recommendation and any additional information necessary. After all information is collected, the committee recommends three nominees to the Board of Directors for final determination.

Agency-Level Awards

Each Teaching-Family Association Certified Member Agency may submit the name of one of their Practitioners for the agency's recipient of the *Teaching-Family Association Distinguished Service Award*.

Each Teaching-Family Association Certified Member agency may submit the name of an individual or organization for the agency's recipient of the *Agency Award for Outstanding Achievement & Advancement in Human Services*.

Formal letters of nomination are not required for agency level awards. Agencies are encouraged to develop their own policies and procedures, however, for recipient selection. The Teaching-Family Association's only requirements is that any practitioner must be formally affiliated with a Certified Member Agency and have demonstrated exceptional performance.
